Note :

- (1) Only companies who have proven credential and capability of manufacturing, supplying and installing gas fired kilns to academic/R&D institutes and ceramic/materials processing industries in India and abroad may respond and participate in the pre-indent conference. The participating companies should submit their audited balance sheet for the last three years to the expert committee of CSIR-CGCRI on the day of the meeting.
- (2) The companies willing to participate in the pre-bid conference should send their expert technical personnel to attend the meeting for answering all technical queries on the day of the meeting. No request for submitting information on a later date will be entertained.
- (3) The companies should submit technical literature describing their products and capabilities, especially with reference to gas fired kilns to the expert committee of CSIR-CGCRI on the day of the meeting
- (4) Any Indian agent of a foreign OEM may participate in pre indent conference only if they have applied/obtained DGS&D registration as per Ministry of Finance, Department of Expenditure OM No. F 23(I)E.III(A)/89 dated 31/01/89 read along with Rule 143 of General Finance Rules, 2005.

As per Ministry of Finance, Department of Expenditure OM No. F 23(I)E.III(A)/89 dated 31/01/89 read alongwith Rule 143 of General Finance Rules, 2005, it is mandatory for Indian Agents, who desire to quote directly on behalf of their foreign principals to get themselves registered with DGS&D. However, such enlistment is not equivalent to registration of supplier as mentioned under Rule 142 of GFR, 2005 (relating to registration of vendors). Any bids submitted by Indian Agents not enlisted with DGS&D are to be summarily rejected.
