2.0 Qualifying Requirements

- 2.1 The bidder should have designed, manufactured, supplied, erected and commissioned minimum one no. of transport crawler of not less than 470 Tonnes (Centered Arranged Load) capacity for shifting conveyor drive head stations and this equipment should have worked satisfactorily in any mines for a minimum period of 3 years as on the original scheduled date of tender opening.
- 2.1.1 A bidder who does not meet the above qualifying requirements can also participate if
 - (a) the bidder shall furnish satisfactory evidence that he has a valid collaboration agreement with a collaborator or collaborators or valid consortium agreement with consortium member(s) jointly or severally fully meeting the qualifying requirements stipulated as in clause 2.1 above, along with bid and
 - (b) the bidder shall furnish an undertaking jointly (JDU) executed by him and his collaborator(s)/ consortium member(s) to guarantee the standards of performance of the equipments as detailed in the tender specification along with bid.
- 2.2 The bidder who does not meet the above qualifying requirement, can also participate along with an associate, if the associate is the Parent/Principal/ Group company of the bidder (who fully meets the qualifying requirements singly or jointly i.e the associate by themselves or along with the bidder, stipulated as in clause 2.1 above). However, in such cases, the bidder and his associate shall furnish a joint deed of undertaking (JDU) to guarantee for the standards of performance of the equipment as detailed in the tender specification.

- 2.3 The bidder and their collaborator(s)/ associate / consortium member(s) as the case maybe shall have adequate financial stability and status to meet the financial obligations pursuant to the scope of work and has handled previously contracts of this type and magnitude. The Annual reports containing Profit and Loss account and Balance sheet for the last 3 years shall be enclosed. The bidder and their collaborator(s)/ associate/ consortium member(s) should have positive net worth, as per latest audited financial statements.
- 2.4 The bidder and their collaborator(s)/ consortium member(s) as the case maybe shall have valid JDU with member(s), such JDU shall be in force as on the scheduled original tender opening date and shall be further valid at least up to the completion of the proposed contract.
- 2.5 The bidder shall furnish the name of the electrical supplier along with documentary evidences, such as copies of purchase order and performance certificate from the user or original supplier of the equipment.

2.6 Other Conditions:

- 1. Notwithstanding anything stated above, the purchaser reserves the right to assess the bidder's capacity and capability to perform the contract, should the circumstances warrant such an assessment in the overall interest of the purchaser.
- 2. Documentary evidences, such as copies of purchase order and performance certificate from the user, shall be furnished. Bids which are submitted without proper documentary evidences to substantiate fulfillment of the qualifying requirements as specified are liable for rejection without assigning any reason.
- 3. The bidder who has already supplied such equipment to NLC, will be qualified based on the performance with NLC, subject to meeting the above Qualifying Requirements. However, the references of previous supplies should be furnished.
- 4. The successful bidder meeting the qualifying requirements with Collaborator(s) or associate or consortium member(s) as the case maybe, shall furnish a Contract Performance Guarantee in the form of an on demand Bank Guarantee for the faithful performance of the Contract for a value of 10% of the total Contract price after the award of LOA. In addition the Collaborator(s)/ associate /consortium member(s) shall each furnish a backup Bank Guarantee for 5% of the respective portion of work.

3.0 Scope of Work.

3.1 The scope of work shall include Design, manufacture, fabrication, supply, assembly/erection, commissioning, testing and handing over of all mechanical, structural and electrical components and Take Over Test (TOT) of 1 No. of Transport Crawler complete, with a loading capacity of 640 Tonnes centered arranged load on turn key basis for Mine IA and complete maintenance of the Transport Crawler during warranty period & three years after warranty period.
